CONSOLIDATED FINANCIAL REPORT

For the year ending December 31, 2021



Overview

This report provides a consolidated overview of the financial position of the Global Partnership for Education Trust Fund for the year ending December 31, 2021. This report provides details on the cash flows of the GPE Fund, including contributions, and program implementation grant disbursements. The previous Catalytic Funds were closed in December 2018 and details are given in Annex 1 and 2.

While the challenges of the COVID crisis continued to impact GPE throughout 2021, following a successful replenishment conference in July 2021, GPE was able to raise approximately US\$4 billion, allowing GPE to set aside nearly US\$4.2 billion in new allocations. Approvals for the year approached US\$750 million and while the pressures of COVID are expected to continue to have an impact at country level for the foreseeable future, the announcements of cohorts one and two will allow partner countries to begin preparations for their next System Transformation Grants.

Summary of Financial Position

The GPE fund balance held in trust (i.e. Cash) at December 31, 2021 was US\$1,045.1 million, an increase of US\$165.2 million from the balance held at December 31, 2020 of US\$879.9 million. The increase reflects the large increase in donor contributions that occurred following the replenishment.

Of the cash balance, approximately US\$128.7 million was either committed (i.e. set aside to make transfers/disbursements based on existing funding decisions) as of December 31, 2021. The overwhelming majority is committed for program implementation grants.

As of December 31, the balance of funds that were uncommitted and therefore available to make new commitments was **US\$916.4 million**, However due to GPE's approach of only committing funds in annual instalments for program implementation grants, the majority of these funds are required to fund commitments for the outer years for program implementation grants approved by the Board from 2017 through 2021.

Donor Contributions during the year amounted to US\$835.4 million* while transfers out of the Trust Fund amounted to US\$666.3 million*. Disbursements of funds in the year for grant related financing totaled US\$593.7 million*, which excludes any refunds (cumulatively US\$6,441.9 million* has been disbursed for grant financing as of December 31, 2021).

^{*}Some of the figures in the report differ from other World Bank issued reports as the Secretariat locks the value of euro fund contributions not exchanged into US dollar at the time of receipt and values euro fund disbursements using the FX rate at the time of grant approval. The Trustee, however, uses a floating rate that is only updated at the time of the issuance of a report. The values contained in Table 1 match the December 31, 2021 Trustee Quarterly Report, whilst other values may not match due to the different FX rate. The totals in the tables and annexes may not add up due to rounding.

^{*}The figures in the tables 1 and 2 above match what is shown in the Trustee Report, as of December 31, 2021. They will differ from figures provided above on page 1, paragraph 6, and Table 3 due to the management and recording of contributions to and disbursements from the euro fund. The Trustee values the contributions to the euro fund by providing a US dollar value of the funds at the time of the financial report whereas the Secretariat uses a specific exchange rate to value the euro grants and the contributions to the fund.

Inflows are comprised of funding primarily from the public sector through sovereign governments, along with funds from Private Foundations. Other sources include refunds from grants, and investment income.

Outflows refer to transfers of funds out of the Trust Funds. The majority of Outflows are for **Projects** (Program Implementation Grants, Multiplier Funding, Education Plan Development Grants, Program Development Grants, Education Out Loud (and its predecessor the Civil Society Education Fund), Knowledge and Innovation Exchange (and its predecessor "Global and Regional Activities"). Other Outflows relate to agency fees, supervision allocations, and administrative costs such as the Secretariat budget, the Trustee budget and administrative fees.


Cash balance represents actual cash in the Trust Funds and is either committed (i.e. set aside to finance existing obligations such as program implementation grants approved by the Board but where funds have not been transferred) or uncommitted (i.e. available to be used to finance new allocations).

Where the contribution amount is in a currency other than USD, the exchange rate used to value the receivable is the rate as of December 31, 2021.



Grant Amount is the cumulative value of approved program implementation grants and multiplier funding since inception. **Committed** represents the amount of funding set aside by the Trustee that can be drawn down at any time by the grant agent. A formal commitment locks the funding away in the GPE Trust Fund so that it cannot be used for any other activity or purpose. Grants are approved with a duration of several years, funds are committed in annual instalments to avoid tying them up ahead of need. The **Disbursed** columns represent the cash that is transferred from the Trust Fund(s) to the Grant Agent. The **Utilization** columns represent further disbursements or expenditure reported by the grant agents based on funds received from GPE. It should be noted that the timing and frequency of when Grant Agents submit reports can mean reported utilization rates are lower than actual rates at the dates shown.
